Press release issued May 14, 2007 in which the Registrant announced that it has received a total of C\$13.5 million from Xstrata plc (formerly Falconbridge Limited) pursuant to Xstrata's exercise of half of the two million Seabridge share purchase warrants it holds. The warrants were issued to Xstrata as part of the consideration by which the Registrant repurchased a 100% interest in its Kerr-Sulphurets project. (See news release of September 5, 2006). Each warrant permits the holder to purchase one common share of the Registrant for C\$13.50 until February 20, 2012.
