American Realty Investors, Inc. ("ARI") is unable to file its Annual Report on Form 10-K for the year ended December 31, 2003 without unreasonable effort and expense due to incomplete data from its 80%-owned subsidiary, Transcontinental Realty Investors, Inc. ("TCI").

PART IV - OTHER INFORMATION

(3) For the year ended December 31, 2002, ARI had a net loss of approximately \$10.9 million. For the current period ended December 31, 2003, ARI is currently estimated to have approximately "break even" results.
