This Schedule 13G (the Schedule 13G) is being filed on behalf of Fir Tree Value Master Fund, L.P., a Cayman Islands exempted limited partnership (Fir Tree Value), Fir Tree Recovery Master Fund, L.P., a Cayman Islands exempted limited partnership (Fir Tree Recovery) and Fir Tree, Inc., a New York corporation (Fir Tree), relating to common stock, par value \$0.01 (the Common Stock) of Encore Acquisition Company, a Delaware corporation (the Issuer), purchased by Fir Tree Value and Fir Tree Recovery. Fir Tree is the investment manager of both Fir Tree Value and Fir Tree Recovery.

- (a) Fir Tree Value and Fir Tree Recovery are the beneficial owners of 2,434,920 shares of Common Stock and 509,980 shares of Common Stock, respectively. Fir Tree may be deemed to beneficially own the shares of Common Stock held by Fir Tree Value and Fir Tree Recovery as a result of being the investment manager of Fir Tree Value and Fir Tree Recovery.
- (b) Fir Tree Value and Fir Tree Recovery are the beneficial owners of 4.6% and 1.0%, respectively, of the outstanding shares of Common Stock. Collectively, the Reporting Persons beneficially own 2,944,900 shares of Common Stock which represent 5.5% of the shares of Common Stock outstanding. These percentages are determined by dividing the number of shares of Common Stock beneficially held by 53,126,504, the number of shares of Common Stock issued and outstanding according to the Issuer's Form 8-K filed with the Securities and Exchange Commission on July 6, 2007.
- (c) Fir Tree Value may direct the vote and disposition of 2,434,920 shares of Common Stock. Fir Tree Recovery may direct the vote and disposition of 509,980 shares of Common Stock. Fir Tree has been granted investment discretion over the Common Stock held by Fir Tree Value and Recovery.
