- (1) Each Apollo Operating Group unit represents a right to receive one Class A share of Apollo Global Management, LLC (the "Issuer"), subject to the restrictions and provisions set forth in the Exchange Agreement, dated July 13, 2007, and as amended and restated May 6, 2013, between the Issuer, the reporting person and the other parties thereto (the "Exchange Agreement").
- (2) On May 14, 2013, the reporting person distributed 8,769,364 Apollo Operating Group units to certain persons. These Apollo Operating Group units were exchanged by those persons for Class A shares of the Issuer on a one-for-one basis pursuant to the Exchange Agreement. As a result, the Issuer's percentage ownership in the Apollo Operating Group increased, and the reporting person's percentage ownership in the Apollo Operating Group decreased.
- (3) The Apollo Operating Group units do not expire.
