### CSX COMMENTS ON TCI COUNTERCLAIMS

Jacksonville, FL – April 4, 2008 – CSX Corporation (NYSE: CSX) today issued the following statement in response to the counterclaims filed by The Children's Investment Fund (“TCI”) against CSX and Michael Ward, CSX chairman, president and CEO:

“CSX believes that TCI has filed counterclaims in an attempt to distract shareholders from the Company’s previously filed lawsuit against TCI, 3G Capital Partners and certain of their affiliates. In its complaint, CSX alleges violations by TCI and 3G of federal securities laws that would effectively undermine the integrity of the voting process at the CSX annual meeting. CSX is committed to protecting the interests of all shareholders and to continuing the Company's industry-leading record of shareholder value creation. The Company believes the TCI counterclaims are without merit and will defend against them vigorously.”

CSX Corporation, based in Jacksonville, Fla., is one of the nation's leading transportation companies, providing rail, intermodal and rail-to-truck trainload services. The company's transportation network spans approximately 21,000 miles, with service to 23 eastern states and the District of Columbia, and connects to more than 70 ocean, river and lake ports.
