Item 1.01. Entry into a Material Definitive Agreement.

On August 13, 2009, Praxair, Inc. (the "Company") issued \$600,000,000 aggregate principal amount of 4.500% notes due 2019 (the "Notes"). The Notes were sold in a registered offering under the Securities Act of 1933, pursuant to the Company's shelf registration statement on Form S-3 filed with the Securities and Exchange Commission ("SEC") on December 14, 2006. The material terms of the Notes are described in the Company's prospectus supplement dated August 10, 2009 filed with the SEC on August 11, 2009.

In connection with the issuance of the Notes, the Company entered into a Terms Agreement dated August 10, 2009 (the "Terms Agreement") with Banc of America Securities LLC, Credit Suisse Securities (USA) LLC and HSBC Securities (USA) Inc., as representatives of the underwriters named therein (the "Underwriters"). Pursuant to and subject to the terms and conditions of the Terms Agreement, the Underwriters agreed to purchase the Notes from the Company for resale in the registered offering. The Terms Agreement is filed as Exhibit 1 to this Form 8-K.

In connection with the Notes offering, Cahill Gordon & Reindel llp provided certain legal opinions to the Company that are filed as Exhibit 5 to this Form 8-K.
